## Conditions of Entry 2024 Halloween Themed Silent Disco in the Sky

## Entry to the Sands SkyPark Observation Deck at Marina Bay Sands is subject to the following conditions:

- All ticketholders must be 18 years of age or older. A valid photo ID will be required at the point of entry – NRIC, Passport, Driver's License or Employment Pass are acceptable forms of photo IDs
- Wristbands issued for the event must be worn at all times within the venue.
- Wristbands are strictly non-transferrable. Marina Bay Sands ("MBS") reserves the right to deny entry to guests if wristbands are found to be tampered with or damaged.
- External food and drinks are strictly not allowed within the venue.
- Seats and tables are available at the event venue at a first-come-first-served basis.
- Guests who appear intoxicated may be refused entry based upon the sole discretion of MBS Management.
- The venue is a smoke-free area. Smoking is permitted only in designated areas outside of the building.
- All guests may be subject to a security search, including bag check. Guests who do not agree to be searched may be denied entry into the event or escorted off the property.
- Whenever a guest is not permitted to enter the Sands SkyPark Observation Deck or when a guest
  is escorted out of the Sands SkyPark Observation Deck for any reason, no refund will be paid in
  respect of his or her ticket.
- In addition, MBS Management reserves the right to cancel or suspend the event and/or close the SkyPark Observation Deck in the event of rain or lightning or in MBS Management reasonable opinion it is not safe to continue with the event.
- The right of admission is reserved and is subject to MBS' Conditions of Entry.
- Whilst umbrellas are not prohibited, it is strongly recommended that guests do not open them
  while on the Sands SkyPark Observation Deck the area is subject to strong gusts of wind. MBS
  Management takes no responsibility for loss of items or injuries sustained.
- Aggressive behaviour, harassment, or inappropriate conduct will result in removal from the event.
- By attending the event, guest consents to being photographed or recorded with the footage
  potentially used for promotional purposes. If you do not agree to the foregoing, please do not
  enter the venue or alternatively, please contact our staff for arrangements to be made where
  possible, to exclude you from any photography, filming and/or recording.

• Guests are allowed to take personal photos but personal professional photography or recording equipment is not permitted without MBS' prior permission.

## **Costume Requirements:**

- Guests are encouraged to come in Halloween-themed costumes.
- Facemasks and excessive makeup must not obstruct identification or violate MBS' security checks.

• Costumes deemed offensive, inappropriate, or culturally insensitive by MBS or venue staff will not be tolerated. Guests wearing such costumes may be asked to change or may face immediate removal from the event without a refund.

## **Prohibited Items:**

The following items are PROHIBITED and therefore not permitted into the Sands SkyPark Observation Deck:

Glass containers of any kind, external food & beverages, flowers, pets (only service animals are permitted), aerosol cans, firearms, knives, box cutters, weapons of any kind, chairs, signs, sticks (including selfiesticks), poles, laser pointers, whistles, air horns, bull horns, fireworks, illegal substances/narcotics, pepper spray, mace, and any item deemed by management to be dangerous or inappropriate.

Unlawful items that are discovered during security checks are subject to being confiscated and the person in possession of those items may be handed over to the Police.
